1.0 Call to Order

Chairman Rappold called the Host Communities Standing Committee meeting to order at 12:00 p.m.

2.0 Roll Call

Ms. Melloni called the roll; a quorum was established.

Chairman Rappold indicated that the minutes were reviewed and appear to be in order. Mr. O'Donnell made a motion, seconded by Mr. Dumphrey, to approve the minutes of March 27th and May 22nd, 2012. Motion passed.

5.0 Project Presentations

5.1 Niagara County

5.1.1 "From the Mouth of the Lower Niagara River Commemorating 200 Years of Peace on Our Border"

(\$29,000 - Approved by Niagara County Legislature 6/19/12; Determined Consistent by NRGC 5/15/12)

Gretchen Duling reviewed the project sponsors and contributors. She provided a presentation by reading an excerpt from the proposed publication. She explained that the Historical Society of Lewiston accepted the responsibility of the 501C3 in order to distribute the funds, any grants, donations or awards the publication will get. She explained that their addendum successfully addresses the guiding principles. In looking at the initial Greenway requirements they feel the project reflects the spirit of the Greenway. She stated that she feels the criterion meets the requirements of the NRGC. They may need some additional funding and have recently received some information from the Bridge Commission. She reviewed their budget which included volunteer hours and related expenses.

Ms. Duling discussed how the book will be distributed in the United States and Canada. The price of the book will be the same on both sides of the border. She expressed their gratitude to Legislators Michael Hill and Clyde Burmaster and the support of the Niagara County Legislature. She also reviewed various letters of support from the City of Niagara Falls and Town of Lewiston. They believe the book benefits local residents and visitors of the Niagara River Greenway corridor.

Mr. Massaro asked how this was consistent with the Greenway. Mr. Burgasser stated that many people thought this was a great idea. The NRGC indicated that this was something that was able to tie together a good portion of the Greenway and what the projects represent along the Greenway itself, and therefore in their minds, and Niagara County also felt, it becomes consistent to tie these things together. A portion of the funds from the sale of the book will be held by the Historical Society in order to update the book also.

There were no further questions or comments from the members. Mr. Widger stated that the project has met all criteria to bring it to a vote.

5.1.1 "From the Mouth of the Lower Niagara River Commemorating 200 Years of Peace on Our Border"

Mr. Ross made a motion, seconded by Mr. O'Donnell, to approve funding in the amount of \$29,000.00 for the "From the Mouth of the Lower Niagara River..." Project.

Duling, Ph.D.**, has applied to the Host Communities Standing Committee for funding in the amount of **\$29,000.00** for the **"From the Mouth of the Lower Niagara River"** project and; WHEREAS, this project was submitted to the Niagara River Greenway Commission for consultation;

WHEREAS, the Host Communities Standing Committee finds the project to be consistent with the Greenway Plan.

5.0 Project Presentations

5.1 Niagara County

5.1.1 "Kiddieland by Carousel Society of the Niagara Frontier"

(Requesting \$66,000 additional funding – approved by N.C. Legislature; \$30,000 approved by N.C. Legislature on 1/18/11; Determined Consistent by NRGC on 1/19/10)

Rae Proefrock, Director of the Carousel Museum, addressed the members. She explained that when the project was started they hoped to put a fence around the land, approximately a 100 x 150 s.f. space. There are concrete pads and a pavilion to provide some shade for parents. The pads would allow them to set up four rides, three of which are from the former Pages Restaurant in Niagara Falls and the fourth ride was donated. This was done with the \$30,000 from the Greenway funds and \$35,000 from the City of North Tonawanda. She explained that they are purchasing the rides for \$12,000, but the project requires another \$70,000 to \$80,000. They realized that they would have to take the rides down every single year and store them somewhere and then put them back up each year. This would be difficult for their older volunteers. The additional funding will allow them to put an octagon shelter over three of the rides, as the helicopter ride cannot be covered. That shelter will allow them to board it up to protect the rides during the winter months. They also decided they would like to add nice fencing, pavers, lighting and landscaping. This brought the cost up to \$216,000. An anonymous donor is providing \$150,000, providing the Greenway will approve funding for the remaining \$66,000.

Mr. Ross made a motion, seconded by Mr. Dumphrey, to approve additional funding in the amount of \$66,000 for the "Kiddieland" project.

"WHEREAS, the **County of Niagara**, on behalf of the **Carousel Society of the Niagara Frontier**, has applied to the Host Communities Standing Committee for additional funding in the amount of \$66,000.00 for the **Kiddieland Project**; and WHEREAS, this project was submitted to the Niagara River Greenway Commission for consultation; WHEREAS, the Host Communities Standing Committee finds the project to be consistent with the Greenway Plan. Mr. O'Donnell made a motion, seconded by Mr. Reiter, to authorize the Secretary of the Host Communities Standing Committee, Ms. Cynthia Bianco, to certify the individual signatures of the members to First Niagara Bank. Motion passed.
